What is this product?

The Company is an open-ended fund with no specified maturity date.

Objectives

The Product aims to achieve long term capital growth with lower volatility than a Product which invests solely in equities. The Product is considered to be actively managed, which means that the Investment Manager is not constrained by any index or benchmark in the selection of investments. The Investment Manager has discretion in managing the investments of the Product. The Product seeks to achieve this objective by investment primarily in open ended collective investment schemes which gain exposure to equities (e. g. shares), Fixed Income Securities (with no restriction on the minimum credit rating), property, commodities and currencies. The Product may gain exposure in the range of 20-60% of net assets to equities and long only Products; and will maintain a minimum exposure of 30% to Money Market Instruments, Cash and Products which invest in Fixed Income Securities. Macro considerations will be used in determining the allocation of investments in order to achieve the Product's investment objective. The Advisor will provide advice and recommendations to the Investment Manager as to suitable target Underlying Funds for investment, in accordance with the investment strategy of the Product and based upon the strategic asset allocation views of the Investment Manager. Any income arising from this Share Class will be accumulated. The Product may use a number of simple derivative instruments for investment purposes and/or

efficient portfolio management purposes. Further information on the Product's use of derivatives can be found under the Derivatives section within the Product's Supplement. Although the use of derivatives may give rise to an additional exposure any such additional exposure will not exceed the Product's Net Asset Value.

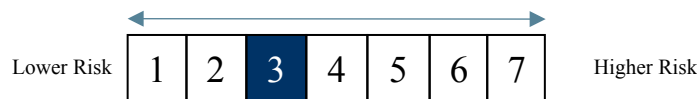

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the PRIIPs manufacturer to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

Performance Scenarios
